Horsewatch schemes are in place to offer advice about crime prevention. Such advice is centred towards the equine community but equally such advice can diversify to other areas all of which can affect the equine community. The below information is shared for your benefit. It would be nice to think that some advice is taken up. Horsewatch schemes can advise and suggest but it is you the equine community that have to actually put crime prevention methods in place.

The below information comes from Dorset Police but the message remains the same for everyone.....just replace Dorset for your county. Remember for all Police Forces in England and Wales there is just one number to phone for non emergencies, that is 101

Door-to-Door Sellers

There have been recent reports in East Dorset of door to door sellers offering services such as new drive-ways. Dorset Police discourage any resident from purchasing services or products from the doorstep, and would always urge you to seek numerous written quotes before accepting any work. There is a seven day cooling-off period for any sales over £35.00 at the doorstep for the consumer to withdraw from a contract.

One of the most recent door to door sales we have seen in the East Dorset area is people asking to purchase from you any pens, medals and coins etc. The individuals are very smartly dressed and quite polite. Although the few people who have sold items like this have been happy with the price, these individuals are more than happy to come into your home and help you look for any items they may be willing to buy.

If you have any concerns about people who are calling at your property please do not hesitate to contact Dorset Police on 101. Please try and gather as much information about the caller beforehand such as description and any vehicles.

The information below which comes from Suffolk can easily relate to anywhere in the country.

Horses on the Carriageway

Suffolk Police have, on average, 20 calls a week from members of the public reporting loose horses on the carriageway. Some of these cases involve a horse & rider parting company whilst out riding, however most loose horses are a result of them escaping from fields with inadequate fencing. A lot of valuable police resources are used to make highways safe by capturing the escapees and trying to identify the horses' owners.

A landowner has a duty to ensure that animals kept on their land do not stray, and a claim for damages may lie against a landowner or tenant where it can be shown that the escape was caused by their negligence. Particularly as most fields are adjacent to public roads you could be held legally responsible for any accident injury or damages incurred by a third party, should your horse escape from his field and venture onto the road.

It might be argued that no fence is totally impenetrable, however a poorly maintained fence which has clear gaps and weaknesses, will expose a landowner to a claim in the event of an escape. What amounts to negligence will, in most cases, be decided on the facts of each case, but the practical approach to maintenance taken by the landowner will usually have a bearing on a court's decision. A patchy fence, or

hedge with gaps, would certainly be cause for concern.



How Not to Fence a Paddock!

Prevention is better than cure. Fences and barriers should be regularly inspected, and a brief note of the dates and outcomes (such as appointments for fencing contractors or report to the landowner) should be kept as these could assist in defeating any negligence claims. Electric fencing has practical benefits, but extreme caution should be exercised if used as the primary barrier in the event of power failure.

If you rent land, although the field is not technically your property, it is still your responsibility to ensure that the fencing is adequate for the purpose for which it is used - this means all reasonable efforts must be made to contain the horses - the fencing must be of adequate height and condition around the whole boundary of the field and the gate and its fastenings must be secure. For legal as well as safety reasons, check your fencing is safe for horses.

Note:- If you call the police to report horses loose on the carriageway, please give as much information as possible such as the road number, the particular location on the road and the names of any nearby properties. It also helps if you know of any horse owners in the area. Please also let the police know when the horse and owner is reunited so we can close the event and avoid unnecessary dispatching of police officers.

Prevention Advice Regarding Break-Ins to Stables & Paddocks

Courtesy of a lady in Cambridgeshire Countryside here is some good advice that may help others to prevent becoming a victim of crime.

Here Are Some Tips:

- Keep the absolute minimum of stuff at your yards/fields.
- Keep the old stuff at your fields, the smart stuff at home (eg headcollars)
- Postcode or phone-number on absolutely everything - headcollars, scissors, rugs, brushes, poop scoops, troughs, water butts, lekkie fencing, batteries. Use a permanent marker pen or a paintbrush and a pot of gloss or enamel paint.
- Cut the twine off your hay once stacked and take the twine home. Loose hay is not impossible to steal, but a darn side harder to steal when it's loose than when it's in a twined bale.
- Buy a SmartWater kit, about £20, and dab it (it's like a pot of nail varnish) onto everything. Then put the Smartwater sticker on your gate/stable warning that stuff is Smartwatered. Paint or write on your wheelbarrow, trough, etc, "Smartwatered"
- Don't post on Facebook or any horse forums that you visit your field at 7.30am and 6pm daily. Keep your routine to yourself. Thieves use the internet too. If you can vary your routine occasionally, that is good.
- If you have dogs, especially big barky dogs, try and be seen down your field on a regular basis, maybe while you're poop-picking, with your dogs, preferably with them running loose.
- Get to know the local dog walkers and birdwatchers who regularly come past your field. They can be

extra pairs of eyes/ears for you.

- Although it's a pain in the arse, work out ways of keeping the absolute minimum of stuff in your yards/fields. Carry the rest back and forth with you. Weigh up the convenience of having stuff at the field permanently with the inconvenience of replacing it regularly because of theft.
- Electric fencing is probably one of the biggest pains. Non-electrified fencing is useless for horses and electrified fencing is a regular free gift for the thief. If you can work out ways of keeping your "neds" without using electric fencing, that will deter thieves from entering your yard/field.

Hope that helps and if any of you have more tips you want to share, please do.

Poaching Awareness

As above the message and advice can easily be said for anywhere else in the country.

Sussex Police would like to raise public awareness in regards to poaching in rural areas. In the last three years Police have worked very closely with rural communities and have had great success in the reduction of poaching of wild animals. Poaching is a secretive business, often carried out at night and in remote locations but if caught, poachers can be prosecuted for a range of offences.

Game dealers, restaurateurs, hotels and public houses are being advised to check that they are not buying illegally killed game. They can do this by not purchasing meat from unknown persons and reporting suspicious gatherings in car parks immediately; dealers in game should show legal documentation for the sale of meat.

Wildlife Crime Officer Chief Inspector Martin Sims said "We would like to encourage anyone to contact the Police with any information that would help in catching poachers, especially if they have been offered meat from sources other than bona fide dealers.

"I'd also like to send a warning to poachers themselves that we are working very closely with farm and land owners and in some cases even install CCTV to catch poachers. It will not be tolerated and we will do all we can to support anyone that this crime affects."

Card Skimming Device Found on Scarborough Cash Machine

Police in Scarborough are warning members of the public to be vigilant when using cash machines. The warning comes after a camera and card skimming device were recovered from a cash machine at the Post Office, Aberdeen Walk in the town. The device was discovered by a member of the public who tried to use the machine. It is unknown how long it had been in place. Officers are appealing for anyone who has seen anyone suspicious loitering in the area of machine to contact them.

Anyone who believes they may be a victim of the skimming device should contact their bank. In the meantime officers have repeated their advice to customers when using cash machines. PC John Coleman who is investigating the incident, said:-

"The most important thing is to cover your hand while you are typing in your pin number, without your pin, thieves have limited opportunity to use the card. Thieves use very sophisticated technology and the devices are often very difficult to spot. The devices will often be made to fit in with the colour and design of the machine they are attached to. They consist of a card-reader which is placed over the card slot which records your card's details and a tiny pin-hole camera which records your pin number as you type it in. In some cases a cover is placed over the keypad which can also record your pin number. The camera is usually stored in a strip of metal or plastic which looks like trim and is often coloured to match the machine. The camera lens is almost invisible. Please report any suspicions you have about a machine to the police and the premises in which the machine is based. Don't under any circumstances

try to remove the device yourself as the offenders may still be in the area."

Anyone with any information which could help the investigation is asked to ring North Yorkshire Police on 101. Or you can pass information to Crimestoppers anonymously on 0800 555 111. To report a suspicious device, call 101 immediately. Cash machine safety Protect your PIN by standing close to the machine and shielding the keypad with your other hand. Check to see if anything looks unusual or suspicious about the cash machine. If it appears to have anything stuck onto the card slot or keypad, do not use it. Cancel the transaction and walk away. Never try to remove suspicious devices, report them to the police and the bank immediately. Be cautious if strangers offer to help you at a cash machine, even if your card is stuck or you are having difficulties. Don't allow anyone to distract you. Where possible use a cash machine which is in clear view and well lit. Check that other people in the queue are a reasonable distance away from you. Keep your PIN secret. Never reveal it to anyone, even someone who claims to be calling from your bank or a police officer. Avoid opening your purse, bag or wallet when you are in the queue. Put your money away immediately. Regularly check your account balance and bank statements and report any discrepancies to your bank immediately.

Scam Facebook e-mail

Beware: New malware disguises itself as Facebook photo notifications. The public are being warned to be careful about opening unsolicited email attachments, after a malicious Trojan horse was spammed out posing as a Facebook photo notification. The email has attached a ZIP file which contains malware, designed to allow hackers to gain control over your Windows computer. The email reads as follows-

Subject: Your friend added a new photo with you to the album
Attached file:New_Photo_With_You_on_Facebook_PHOTOID[random].zip
Message body:
Greetings,
One of Your Friends added a new photo with you to the album.
You are receiving this email because you've been listed as a close friend.
[View photo with you in the attachment]

Do not open the attached ZIP file as the malware will infect your computer. If you receive an email from a friend on Facebook that states someone has added a new photo of you always check on Facebook directly if you are not sure it's legitimate.

Lottery Fraud

The National Fraud Intelligence Bureau is issuing a warning about a suspected lottery fraud that is being used to secure victims personal details rather than their money. To date analysts have identified what appears to be four separate scams where people are receiving individually addressed letters saying they have won either the Microsoft, FIFA Euro 2012 or Euro Millions lotteries.

Recipients of the letters are informed they need to complete a claims form to indicate whether they want to receive their winnings by cheque or bank transfer, which must then be either emailed or faxed back to the companies allegedly operating from the following addresses:

- 99 Gresham Street - Microsoft Lottery: asks recipients to respond by email Canada Square, Canary Wharf E14 - FIFA Euro 2012 Lottery: ask recipients to respond by fax to Northwest Financial Consultants
- 16 Eastcheap London EC3 - Euro Millions Lottery: ask recipients to respond by email
- 1 Ropemaker Street EC2 - Euro Millions Lottery International: Alf Europe Consultants or Alpha Funds & Wealth Management UK or Haworth Security Ltd: ask recipients to respond by fax

All of the above addresses house legitimate businesses that have no association with the companies

listed above. In each case victims are not being asked for any fee, but instead their credentials including bank details which could be used to commit another crime. The National Fraud Intelligence Bureau (NFIB) first became aware of the suspected fraud after people without access to email or fax, or who misunderstood the instructions, posted their claims forms back to the listed addresses. This inadvertently prevented their details being disclosed to the fraudsters. As the number of letters arriving increased, security at all four locations became suspicious and notified the police. The NFIB has since suspended the phone lines, only for them to quickly re-emerge under the guise of an alternative company name. DC Alex Eristavi, from the NFIB, said:- *On this occasion it appears that fraudsters are preying on people's hopes and dreams to secure personal information now, and money later.*

Western Country Watch Weekly - 30th August 2012

Thank you to everyone who provided information relating to sightings of travellers last week. Three separate groups arrived simultaneously at different locations in the New Forest. Early intervention and widespread communication by Police resulted in entry being prevented to land, and all associated vehicles were escorted through the area and into Dorset. One male was arrested as a result of making threats to two males trying to prevent access being gained to land. He has been charged with threatening behaviour.

The NFU Mutual have recently circulated a rural crime survey conducted amongst its' members. The survey identified the items most likely to be targeted by thieves in rural locations. The top ten can be found in the following table (courtesy of NFU Mutual):

Most desired items targeted by thieves – July 2011 – June 2012. Numbers in brackets show the position for the item for 2010-2011
(1) Tools
(3) Heating oil / red diesel
(2) Quad bikes
(5) Metal
(6) Machinery
(4) Tractors
(8) Vehicles (Including Land Rovers)
(10) Livestock

On Tuesday a vehicle was stopped and subsequently the occupants were detected for Theft by Housebreakings at 2 domestic farm dwellings/rural properties and property recovered. Both these had occurred during the morning/early afternoon.

This highlights the fact that farmhouses and associated cottages/properties are identified as being unoccupied for the majority of the day.

If you are leaving your property unoccupied you may want to consider installing an autodialler intruder device. This is a single PIR movement detector that requires a landline telephone connection. You are able to program 3 telephone numbers into the device (ie your mobile, a friend/relatives mob/landline, another family member) and if the device is activated it telephones the numbers in turn until an answer is obtained and then warns that it has been activated.

These devices cost around £20-30 and are available online. They do not give the same coverage as a full house alarm as they only cover one room but are considerably cheaper and give you warning that there has been an activation.

There has also been a report of a theft of diesel from a vehicle on a farm and an adjacent insecure drum that has taken place overnight between Tues and Wed.

The above incidents have happened in the East Neuk area however as you will be aware similar incidents have occurred in other areas of NEF in recent months.

Any livestock are obviously vulnerable whilst on grazing land or in fields. We would advise that anyone with livestock, particularly in remote areas make frequent checks where possible.
